

Resulting from the provisions of the European Union on the protection of personal data introduced under the name of GDPR, we are obliged to inform you that we collect your personal data.

- 1. Based on Article. 13 sec. 1 and sec. 2 of Regulation (EU) 2016/679 of the European Parliament and of the Council of 27 April 2016 on the protection of individuals with regard to the processing of personal data and on the free movement of such data, and repealing Directive 95/46 / EC (hereinafter: GDPR), we inform that the Administrator of your personal data is Versor Engineering Limited Liability Limited Partnership Company (hereinafter: Versor Engineering) based in Bydgoszcz (85-794), Lawinowa 1E/31, tel. +48 52 346 79 48, email address: versor@versor.pl
- 2. Your personal data is processed in order to perform the contract to which you are a party or the entity for which, according to our knowledge, you work for or for which you are a party, and to establish or maintain business relationships, direct marketing of our products and services.
- 3. The legitimate interest pursued by the Administrator is, inter alia, establishing or maintaining business relations with you, the entity indicated in point 1, and direct marketing of our products and services.
- 4. The legal basis for the processing of your personal data is Art. 1 b), c) or f) of Regulation (EU) 2016/679 of the European Parliament and of the Council of 27 April 2016 on the protection of individuals with regard to the processing of personal data and on the free movement of such data.
- 5. Your data, if necessary, may be transferred to processing entities to whom we commission this task, e.g. accounting offices, couriers, banks, insurers, law firms, so that we can perform our contractual obligations resulting from legal provisions and pursue claims and our rights.
- 6. Your personal data will not be transferred to a third country or an international organization.
- 7. Your personal data will not be processed in an automated manner and will not be profiled.
- 8. Your personal data will be processed for the time necessary to achieve the purpose of processing. Due to the statutory limitation periods for civil law claims and the statute of limitations for public law claims, personal data is deleted after 10 years from the end of the year in which the purpose of data processing was achieved.
- 9. In connection with the processing of your personal data, you have the right to:
- a) requests from the Administrator to access your personal data,
- b) requests from the Administrator to correct your personal data,
- c) requests from the Administrator to delete your personal data,
- d) requests from the Administrator to limit the processing of your personal data,
- e) the right to transfer data,

- f) withdrawal of the consent granted to the Administrator for the processing of your personal data at any time, without affecting the lawfulness of the processing,
- g) objection to the processing of data for the purposes of direct marketing of our products and services, which should be submitted to the following e-mail address: versor2@versor.pl.
- 10. If you feel that the processing of your personal data violates the provisions of the GDPR, you have the right to lodge a complaint with the President of the Personal Data Protection Office.
